- V. Club Events and Fundraising
  - A. Betty Di Regolo suggested that the Club only meet every other month during 2021 since it is a non-election year and people are pooped from the 2020 elections and civil strife. Discussion amongst Board members yielded good ideas for the Club to pursue (a future strategic plan, voter suppression battles, gun control policies, civil rights, electoral college debates, possible recall of Gavin Newsom,

the fight to retain the House and Senate in Washington, just to name a few).

After much discussion about keeping members involved in both Democracy and the Club, the suggestion was dropped.

- VI. Frank Martinez proposed that the Board reinstate Bob Shebesta's Club membership.
  - A. In January, the Board voted to suspend Mr. Shebesta's membership based on speech used during a General Meeting that was deemed offensive and hurtful.
  - B. Frank presented the Board with reasons he felt the suspension should be lifted.
  - C. The topic was discussed, each Board member commented. The consensus was to abide by the original ruling.

  - A. Ed talked about the responsibilities of the president for AR Dems.

    - Issues may include unseating Kevin McCarthy (R-CA 23<sup>rd</sup> District), unseating Marjorie Taylor Greene (R – GA 14<sup>th</sup> District)
    - 5. Unseating Republicans who voted to dispute the election results.
  - C. It was reported that Tracie Stafford won the race for the DPSC chair.
  - D. Frank reported that the annual Fair Political Practices Statement was filed in person by him in Sacramento.
  - E. Dori will email Ed and Debbie to set up ZOOM meeting to discuss the president and vice president responsibilities.
  - F. Betty discussed her attendance at the annual Women's March. This year's event was held virtually and aired on Public Access TV. There was also a car caravan around the Capital.

- VIII. The next General meeting was scheduled for Feb.17. Citing a coincidence with Ash Wednesday, Ed Tavares moved to postpone the meeting until Feb. 24 at 7 p.m. Betty Di Regolo seconded the motion. Motion passed on a voice vote.
